Keeping the focus on Civil Rights - Sept. 9th is the anniversary of the Civil Rights Act of 1957. This was the first federal civil rights legislation passed by the United States Congress since the Civil Rights Act of 1875. It was signed into law by Dwight D Eisenhower.

The Civil Rights bill passed congress however opponents of the act were able to remove several provisions and limit its immediate impact. It was this bill that led to Senator Strom

Thurmond to become famous for conducting the longest one-person filibuster in Senate history.

The United States Commission on Civil Rights and the United States Department of Justice Civil Rights Division were established as a result of this bill. More effective civil rights laws were passed in the 60's.

Mark your calendars for Jan. 16, 2022. This is the day NUUF will celebrate the work of Dr. Martin Luther King Jr. and other civil rights leaders.
