### MEMBERSHIP COMMITTEE MINUTES

Membership Committee Meeting  
Monday, April 11, 2022

Meeting called to order at 2:03 p.m.

**Present:** Terry Hoyt (chair), Barb Kane, Candy Sorensen, Cheryl Hanson

**Discussion:** Regarding review of the annual committee report to the board that Terry proposed.

- All agreed that the report was ready to submit.

**Discussion:** Regarding coffee hour following Sunday services and expectations for the annual meeting.

- As chair of the hospitality committee Candy sought direction as to how to reinstate coffee hour, whether to ask for members to sign up to provide food or to have the committee provide it.
- Candy also suggested that there should be modest fare, such as bagels and cream cheese or cookies.
- Terry stated that it would be easier to have the committee provide the food. That was agreed upon.
- Members should be solicited to help clean up after coffee hour.
- Candy will seek direction, via email, as to the board's expectations for hospitality for the annual meeting.

**Discussion:** Regarding the recruitment of new members and the retention of current members.

- The committee raised concerns about the lack of human connection at the Fellowship. Several factors were identified as to causes for this, including but not limited to the response to COVID, aging of members who have passed away or moved, a national trend toward no church affiliation, and separate group allegiances within the Fellowship.
- This committee plans to present these issues after the annual meeting to the newly constituted board with an eye toward finding solutions to the problems.
- The committee developed a list of issues to raise with the board which included the following:

- 
1. Improving the quality and consistency of the services in addition to selecting a single articulate service leader.
  2. Examining the disconnect of members with a shared purpose rather than our current segregation into committees and tribes.
  3. Attracting more men and couples.
  4. Getting to the root causes of why the apathy exists. In other words, diagnosing the problem.
  5. Encouraging the board to plan and lead a membership-wide retreat that is solution oriented. We feel strongly that this is a board responsibility and not the responsibility of an individual committee.

The meeting adjourned at 3:25 p.m.

### **Social Justice Committee**

Human trafficking is a not only State and a Country issue but also a local one.

### **What Is Human Trafficking?**

Human trafficking involves the use of force, fraud, or coercion to obtain some type of labor or commercial sex act. Every year, millions of men, women, and children are trafficked worldwide – including right here in the United States. It can happen in any community and victims can be any age, race, gender, or nationality. Traffickers might use violence, manipulation, or false promises of well-paying jobs or romantic relationships to lure victims into trafficking situations.

Language barriers, fear of their traffickers, and/or fear of law enforcement frequently keep victims from seeking help, making human trafficking a hidden crime.

Traffickers use force, fraud, or coercion to lure their victims and force them into labor or commercial sexual exploitation. They look for people who are susceptible for a variety of reasons, including psychological or emotional vulnerability, economic hardship, lack of a social safety net, natural disasters, or political instability. The trauma caused by the traffickers can be so great that many may not identify themselves as victims or ask for help, even in highly public settings.

### **Indicators of Human Trafficking**

Recognizing key indicators of human trafficking is the first step in identifying victims and can help save a life. Here are some common indicators to help recognize human trafficking.

- Does the person appear disconnected from family, friends, community organizations, or houses of worship?
- Has a child stopped attending school?
- Has the person had a sudden or dramatic change in behavior?
- Is a juvenile engaged in commercial sex acts?
- Is the person disoriented or confused, or showing signs of mental or physical abuse?
- Does the person have bruises in various stages of healing?

- Is the person fearful, timid, or submissive?
  - Does the person show signs of having been denied food, water, sleep, or medical care?
  - Is the person often in the company of someone to whom he or she defers? Or someone who seems to be in control of the situation, e.g., where they go or who they talk to?
  - Does the person appear to be coached on what to say?
  - Is the person living in unsuitable conditions?
  - Does the person lack personal possessions and appear not to have a stable living situation?
  - Does the person have freedom of movement? Can the person freely leave where they live? Are there unreasonable security measures?

Not all indicators listed above are present in every human trafficking situation, and the presence or absence of any of the indicators is not necessarily proof of human trafficking.

The safety of the public as well as the victim is paramount. **Do not attempt to confront a suspected trafficker directly or alert a victim to any suspicions. It is up to law enforcement to investigate suspected cases of human trafficking.**
